1. Purpose.

This policy is designed to articulate eEnergy's commitment to minimising the environmental footprint of its operations.

2. Policy Statement.

 effective remote working.
- Advocate Car Sharing Among Staff: Foster a culture of car-sharing among employees, encouraging them to share rides to reduce individual vehicle use and the associated environmental footprint.
- Support Remote Work for Distant Employees: Offer flexible work-from-home contracts for staff
 residing in distant locations, reducing the need for long commutes, and fostering a better work-life
 balance.



- Promote Sustainable Sourcing: Encourage employees to specify and procure materials that are sustainably produced, ensuring that our operations are aligned with broader sustainability goals.
- Provide Access to Electric Vehicles: Through our company salary sacrifice scheme, offer exclusively
 electric vehicles (EVs), encouraging staff to opt for this environmentally friendly mode of
 transportation.
